



DATA PROTECTION DECLARATION

For Youth Against AIDS (Jugend gegen AIDS e.V.) the protection of your data is a special concern. It is important to us informing you about the handling of your data and your rights in this context.

WHAT PERSONAL DATA DO WE COLLECT?

Personal data are all information that you can be identified with. Depending on the circumstances we collect your name, address, email address, date of birth, nationality, bank account details, phone number, Facebook-URL, school information and project-related letters of motivation.

FOR WHAT PURPOSE AND FOR HOW LONG DO WE USE YOUR DATA?

To ensure the full provision of your requested products and services, we use the information provided by you. In this way you will receive all relevant information related to your membership in Youth Against AIDS or related to the status of the supporter. In addition, we provide you with all necessary resources regarding school partnerships, academies, educational workshops, the placement of condom machines and specific events to actively support your commitment in the sense of the organization. This also includes newsletters.

We will not keep your data longer than it is necessary for the purpose they are processed for. In determining the appropriate retention period for the personal data, we consider various influencing factors such as quantity, type, sensitivity and purpose. In particular, we are examining in this context whether we can also fulfil this purpose by other approaches.



WHAT RIGHTS DO YOU HAVE AGAINST YOUTH AGAINST AIDS?

Regarding the processing of your personal data, you are able to make use of extensive rights. We would like to familiarize them to you:

- **Right of access by the data subject:** You have the right to be informed about the data stored by us, in particular for what purpose the data is processed and for how long the data is stored (Article 15 GDPR).
- **Right to rectification:** You have the right requesting us to correct any personal data concerning you immediately if it is inaccurate (Article 16 GDPR).
- **Right to erasure:** You have the right requesting us to delete your personal data. These conditions provide that you can request the deletion of your data if, for example, we no longer need the personal data for the purposes they were collected or processed for in any other way, if we should process the data unlawfully, or if you should have legitimately objected or have revoked your consent, or if there is a legal obligation to delete (Article 17 GDPR).
- **Right to restriction of processing:** You have the right to request a restriction on the processing of your data. This right exists particularly for the duration of the examination if you have disputed the correctness of the data concerning you, as well as in the case that you wish a limited processing instead of the deletion with an existing right to erasure. Furthermore, processing is restricted in the event that your data is no longer required for the purposes pursued by us, but still required for asserting, exercising or defending legal claims and also if the successful exercise of an objection between us and you is disputed (Article 18 GDPR).
- **Right to data portability:** You have the right to receive your personal data you have provided to us in a structured, common, machine-readable format (Article 20 GDPR), as far as these have not been deleted already.

CAN YOU REVOKE A CONSENT THAT IS ALREADY GIVEN FOR DATA PROCESSING?

You can revoke your consent to the processing of personal data at any time free of charge and with effect for the future. This also applies to declarations of consent issued before the EU General Data Protection Regulation (25 May 2018).

Declarations of consent can be revoked via e-mail to legal@youth-against-aids.org or mail to Jugend gegen AIDS e.V., Hamburger Straße 23, 22083 Hamburg.

Please note that the revocation will only take effect in the future. Processing that took place before the revocation are not affected by this. The consequence of your revocation might be that without the processing of this data we are no longer able to provide our services in whole or in part and that we must terminate the existing contract if necessary.

CAN YOU OBJECT TO THE PROCESSING OF YOUR PERSONAL DATA?

At any time, you have the right to object to the processing of your personal data for reasons arising from your particular situation (Article 21 GDPR). We will stop processing your personal data, unless we can prove compelling grounds for processing that outweigh your interests, rights and freedoms, or if the processing serves to enforcement, exercise or defense of legal claims.
